8. Reports:

- 8.1. Allan-Thanked everyone for their support over the years and will be available for Marty along his term.
- 8.2. Bruce Buttar did not attend
- 8.3. Resi Walt MSR- Resi and Allan attended the Eastern Ontario Wardens Caucus in Lindsay and did a presentation about Farm 911. Jennifer Moore CAO for Northumberland said they plan to formalize the guidelines for this project in Northumberland by December. There will also be a display set up at the OFA convention in Toronto. Quinte Region Traffic coalition could be a good connection for road safety and farm equipment. Network with more OPP officers through them.
 - Farm & Foodcare have a new release out of their "Dirt on Farming" publication. Copies are mailed to MP & MPP. OFA shared a booth with them at the Royal Ag Fair in Toronto. Farm & Food Care had virtual reality goggles as part of their display so kids could tour farms while the staff talked to the parents. Great idea.
 - Topics or questions that should be addressed at the OFA AGM were chosen. Natural Gas infrastructure, minimum wage implementation, farm property tax increase.

- New copies of the constitution were passed out for each director to put into their binders and new binders were passed to Mark and Marty will deliver Christie's.
- 8.4. Amy, PAC member- Attended the Municipal Ag Economic Development Planning Forum Oct. 18 and the dene of the ON AG College in Guelph was a speaker. He said they were targeting the Peel region for recruits for university ag programs. An afternoon panel was delivering new strategies that municipalities could adopt encouraging the importance of farms in a region for the improved mental health of the community members, scenery being an important tool.
 - Eastern Summit in Brockville touched on the subject of Insurance and due diligence for volunteers. We should look into getting an insurance rep in to talk to us about that topic possibly for January. There was also some talk of Integrated Pest Management policy for county control of noxious weeds. We should discuss this at the next Ag Advisory meeting in Northumberland.

It is important to keep agriculture representation at these events because they have a different mindset than conventional agriculture. Good to be aware of any new strategies and have input into any attempts of changing policy in the food industry.

 - Trissia will be attending the wrap up meeting for the Greater Golden Horseshoe Ag system and Natural Heritage System Map and be reporting back to us on the mapping process.
